He married AMANDA MALVINA FITZALLEN HALL⁶³ January 21, 1847 in Butteville, Marion Co, Oregon, daughter of JAMES HALL and CYNTHIA GROOM. She was born August 20, 1828 in Liberty, Clay Co, Missouri⁶⁴, and died December 10, 1915 in Portland, Multnomah Co, Oregon⁶⁴.

Newspaper announcement: Married- At the Bute in Champoeg county, on the 21st of January, 1847, By Rev. J.L. Parish, Mr. W.H. Rees(e) to Miss Amanda M.F. Hall, all of the above mentioned place.

Oregon Journal, 4 Oct 1933, Fred Lockley Interview with Prentice P. Hall of Donald, Oregon: "This house that I live in is built on the old Willard H. Rees claim. He crossed the plains in the same train with John Minto in 1844. Dr. John McLoughlin employed him to build a mill not far from Astoria. In the spring of 1845 he took a contract to build the Catholic church at St. Louis, on French prairie. He bought the claim of Stephen Pelchie... Willard H. Rees, my uncle by marriage, went down to California in the fall of 1848 on horseback and mined on the Mokelumne river. He came back with something over \$3,000 in gold dust. He did contracting and building for a good many years."

placed in their research library. Surely this is the same person! My grandmother gave these letters to my dad. She obtained them while she was Head Housekeeper at

the Masonic Home in Forest Grove, Oregon. When the residents passed away their personal belongings were sold if no family members wanted them.

The first letter is dated 20 March 1846 at Oregon City, OR and addressed to his mother Mrs. Elizabeth L. Rees of Riley, Butler Co., OH. It indicates that he came to Oregon about 1844 or 1845. The second letter is dated 22 October 1848 at Sutter's Fort in California (Gold Rush time!) and addressed to Mrs. Amanda M. Rees of Champoeg, OR.

I have typescript copy of both if you are interested.

Coincidentally, my husband descends from a Rees family that was also in Ohio but I don't know if there is a connection.

Mr. and Mrs. James Elliott Hall, was born in Liberty, MO., August 30, 1826. With her parents, she crossed the plains to Oregon in 1845, the family arriving at Oregon City just before Christmas. They stayed at Oregon City until the Spring of the following year when they moved to Butteville, a few miles below Champoeg. Here Mr. Hall began making arrangements for locating on a donation land claim on the lower French Prairie. A large house was rented from one of the settlers and Mrs. Hall and daughters kept a tavern. To this house came the handsome and successful young lover, Willard Hall Rees to tell his love to the beautiful Miss Amanda Hall, whom he had met in Oregon City during the preceding Winter. On January 21, 1847, Willard H. Rees and Miss Amanda M. Hall were married at Butteville, the wedding ceremony being performed by Rev. J. L. Parrish. Mr. and Mrs. Rees moved to a farm of 640 acres which he had previously purchased from a Canadian settler. There they lived continuously until 190, except for a brief period in 1851 and 1853, when they conducted a tavern in Champoeg. In January 1900, they moved to Portland and lived with their son, Dr. P.A. Rees. To Mr. and Mrs. Rees were born 13 children, six sons and seven daughters. One son was lost in early infancy, but the others grew to maturity. The daughters now living are: Mrs. James William Welch and Mrs. William Hendershott, of Portland; Mrs. John S. Clark, of LaGrande; Mrs. C.H. Day, of Dayton, Wash., and Mrs. H. Augustus Wright, of Portland. The sons are : D.D. Rees, T.H. Rees, P.A. Rees, and Willard H. Rees, of Portland, and H.L Rees, of Trinidad, Wash. There are 26 grandchildren and 15 great-grandchildren."

P. O. Cane Ridge; was born in Prince William County, Va., Feb. 22, 1812; to Capt. Chas. and Victoria (Tebbs) Meng; she a daughter of Captain Wm. Tebbs and a Miss Harslip. A singular incident relating to the birth of Major Meng, is the fact that he was born upon the same day of the month upon which the birth of Geo. Washington

occurred, and that his father, Chas. Meng, and Capt. Wm. Tebbs, his grandfather, were both Captains under that illustrious General. Captain Chas. Meng, a son of Chas., Sr., who came from Holland to this country at an early date settled in Virginia. The father of our subject, being born in Winchester, where he lived until fifteen years of age, when they moved to Woodstock, where in later years he became a merchant of wealth and prominence. Inheriting a great amount of property from his wife, he moved to Prince William County, the land of her nativity, where he engaged in farming, and raised a family of eleven children, five sons and six daughters. Major Meng is the only one of the sons now living; Charles, two years older than he, the only one of the deceased sons who left issue, became an attorney of some not in Louisville, where he resided for a number of years, subsequently removing to Christian County, Ky. Two only of the six daughters are living: the widow Swing and the widow of Jos. Kennedy, of Washington, D. C. Major Meng came to Nicholas County in Jan., 1833, where he engaged in teaching school, in which capacity he was engaged for some time in Bourbon and Nicholas Counties, subsequently learned the moulder's trade and the business of making plows at Maysville, which he engaged in at St. Louis, but afterward took

up his old occupation of teaching in the vicinity of his present home. He was married in Bourbon County to AMANDA MALVINA FITZALLEN HALL, daughter of

Henry and Fannie (Talbott) Hall, who were among the early settlers of Bourbon County. They had two sons, Charles and James, the mother of whom died on the 15th of April, 1874. The Meng ancestry were a long lived people, the father of our subject sitting as an active magistrate at eighty-two years of have, having held the position of High Sheriff, having come into that position as being the oldest magistrate in the county.

Raymond Ringold Rees told me that Olivia was well-educated; she went to Willamette University. She married well, J.W. Welch, he made a lot of money in shipping and fishing industry. The Oregon Journal, Impressions and Observations of the Journal Man, Fred Lockley, 21 Jan 1927:

Lives at 583 E. 24th Street; born 23 Sept 1850 at home; Willard Hall Rees bought claim from Stephen Pelchie in 1845 for \$975; Willard and Amanda were married on 21 Jan 1847 by Rev. J.L. Parrish; Cynthia Hall was at that time running a hotel at Butteville; In fall of 1848 Willard and Peter H. Burnett went to newly discovered gold fields near Sutter's Fort; Willard took out about \$3,000; Amanda was b. at Liberty,MO on Aug 20, 1828; her father J.E.Hall crossed plains in 1845; they wintered at Oregon City; the old building in which Cynthia Hall, Amanda Hall and the others conducted a hotel in 1846 is still standing; Amanda died at my home; Father died on Jan 18, 1903; I was b. on our family farm, 4 miles from Aurora; the town of Donald is located on our old farm; When I was 8 yrs old, I went to Salem to live with my aunt, Mrs. Evaline Herren; Later I went to Oswego to attend the episcopal school; I attended there in 1860 and 61 ans went back to Salem and went to Willamette Univ when I was 13 yrs. old; I returned to Butteville after several yrs and went to school 2 years to S.W. King and then went to Cove, near La Grande, in Union County, to live with my uncle, M.B. Rees.

Present were 25 pioneers who were in Oregon before 1860. Mrs. Anna Clark, 92, was crowned queen mother by Cheryl Kay Pratt, age six. Mrs. Clark is the daughter of Willard Hall Rees and was born near Butteville Feb 18, 1852. N.L. Jones, Portland, celebrated his 95th birthday at the meeting."

OR Journal, 21 June 1932, Fred Lockley: interview with Ann Rees Clark at 80 years old-in Butteville where she was spending the day with friends. She was born on her father's farm, 15 Feb 1852. Father bought farm in 1845 from French Canadian settler who also raised money to build a Catholic Church at St.Louis. Willard secured the contract for building this church. Mr. Rees was friends with Joseph Gervais, Etienne Lucier, F.X. Matthieu, Wm. Cannon, Louis Labonte, Philip Degie, Archbishop F.N. Blanchet, Dr. Robert Newell, Rev. S.M. Fackler. Anna Rees went to school at Butteville- S.W. King, teacher.

JOHN S. CLARK. - Much interest attaches to this gentleman as the son of one of the earliest pioneers, and as being himself a native of Oregon. The father, Daniel Clark, was well known in the early days as an immigrant of 1844, who married Miss Bertha Herren, whose acquaintance he had formed upon the plains, and who lived near Hillsboro. After his return from the California gold mines, he located in1851 the Clark Donation claim near Salem, upon which both he and his wife died. The son John S., whose name forms the caption of this article, was born near Hillsboro, in Washington, county, Oregon, February 4, 1848. His early life was spent near Salem, where he attended the public school and enjoyed two years of study at the institute. In 1869 he became a pioneer of the Inland empire, coming to the Grande Ronde and pre-empting a claim at The Cove, where he made his home for thirteen years. In 1870 he was married to Miss Anna, a daughter of Honorable Willard H. Rees, the venerable pioneer of Butteville. In 1872 he devoted his attention exclusively to blacksmithing. In 1870 he opened a prosperous business, and

greatly facilitated the harvesting in his section by purchasing a steam threshing machine, with which he operated successfully until the occurrence of an accident, whereby his arm was caught in the belting and torn from the shoulder. This necessitated a change of business; and at the present time he is engaged in the sale of machinery and farm implements in the employ of Frank Brothers of Portland, and has entire charge of their business in Grande Ronde, with headquarters at La Grande.

Mr. and Mrs. Clark, have a pleasant home; and their union has been blessed by three children.

Source For Following Ancecdotal Information: Lee Rose, Sr. 820 S. Beech St Kennewick, WA 99336 (509) 582-7337 Lee told me on the phone 7-21-93 the following: W.W. Day was their family doctor in Dayton, WA After Dr. Day's death, one night " about 2 or 3 a.m. I was awakened by W.W. Day; he said, "Lee, what are you doing about my genealogy?" ' He sat straight up in bed, then woke up his wife and told her what happened. The next day they went to Walla Walla and Dayton and went to work on it. They sent the records to the Temple. He talked to Dr. Day's second wife and she could have cared less about the family history; she was very unhelpful.

"SAD CATASTROPHE. We are pained to learn of the sudden death from drowning of our highly esteemed young friend, Clayton Rees, formerly of Camden, in this county, who at the time of his demise was residing with three brothers on the Solomon river in Kansas. At the time of going to press we are not fully advised of the particulars, but give the information as reported to us. Mr. Rees and his brothers have for some time past, been engaged in stock-raising. He, it appears recently crossed the river with a lot of cattle which he and previously sold. After disposing of the same, and receiving payment therefore had started for home. Upon his return to the river Solomon, he found that recent rains had so swollen it that he hesitated about crossing on horseback. And having a considerable amount of money with him he thought- as is presumed- that it was unsafe to remain there- and hitching his horse, divested himself of a part of his clothing, fastened his money in a belt around his body, and thus undertook to swim across the stream, but from some unexplained cause failed in the hazardous undertaking. His horse was found the day following, and the river in the neighborhood was dragged as soon as possible thereafter, but it was not until some 9 days had elapsed that the body was found! Deeply do we sympathize with the bereaved parents, brothers and sisters of the deceased, in whose sudden exit from Earth's cares they lost a noble son and brother. And many are the friends of the deceased who will mourn his untimely departure. It may truly be sad of the departed, he was a "model young man," whom well to know, was but to love."





Another great source of information is the tribute written by John Minto after Willard's death. It's in the Oregon Historical Quarterly, Dec. 1903.

Newspaper announcement (from Rees Scrapbook): Married- At the Bute in Champoeg county, on the 21st

of January, 1847, By Rev. J.L. Parish, Mr. W.H. Rees(e) to Miss Amanda M.F. Hall, all of the above mentioned place.

Oregon Journal, 4 Oct 1933, Fred Lockley Interview with Prentice P. Hall of Donald, Oregon: "This house that I live in is built on the old Willard H. Rees

claim. He crossed the plains in the same train with John Minto in 1844. Dr. John

McLoughlin employed him to build a mill not far from Astoria. In the spring of

1845 he took a contract to build the Catholic church at St. Louis, on French prairie. He bought the claim of Stephen Pelchie... Willard H. Rees, my uncle

by marriage, went down to California in the fall of 1848 on horseback and mined

on the Mokelumne river. He came back with something over \$3,000 in gold dust.

He did contracting and building for a good many years."

In 1997 I donated two letters written by W. H. Rees to the Oregon-California Trails Association to be placed in their research library. Surely this is the same person!

My grandmother gave these letters to my dad. She obtained them while she was Head Housekeeper at the Masonic Home in Forest Grove, Oregon. When the residents passed away their personal belongings were sold if no family members wanted them.

The first letter is dated 20 March 1846 at Oregon City, OR and addressed to his mother Mrs. Elizabeth L. Rees of Riley, Butler Co., OH. It indicates that he came to Oregon about 1844 or 1845.

The second letter is dated 22 October 1848 at Sutter's Fort in California (Gold Rush time!) and addressed to Mrs. Amanda M. Rees of Champoeg, OR. I have typescript copy of both if you are interested.

Dear Cathi:

Thank you for your May 4th letter and your generous offer to donate the two letters of W.H. Rees to the Merrill J. Mattes Library. We would be delighted to receive the letters.

I have more than a passing interest in the 1846 letter, since I was born in Cincinnati, Ohio(Hamilton County). Butler County is due north of Hamilton County and I have relatives who live near Hamilton and friends who graduated from the Miami University in Oxford, Ohio. There is a small town called Reily located south of Oxford and I suspect that this is the town of Riely where Mr. Rees's mother lived.

The 1848 letter seems to confirm that Mr. Rees had caught a severe case of "gold fever". The discovery of gold by James Marshall in late January, 1848, was a secret that could not be kept. The word of the discovery must have reached Oregon within a few months. The trip from the Willamette Valley to Sutter's Fort would be in excess of 500 miles and it would take from 4-6 weeks even under ideal conditions.

If the letters are folded, I would place them in a double envelope and mail them first class to the above listed address. If the letters are flat, I would place in a file folder or place them between some light cardboard (same thickness as cereal box) and send them. We would be glad to reimburse you for your expense.

I am looking forward to receiving the letters.

Dear Mother while addressing you at this time, I am fearful that you will not receive my letter in consequence of our having no other means of conveyance other than by private travelers, which cannot be relied upon with that degree of confidence & safety as where we have the prevelige of Public posts I wrote several letters addressed to different parts of the U.S.A by Dr Whites party who left this country in Aug last for the States over land, and have just been informed from an authentic source that the party consisting of 4 or 5 individuals were captured & put to death by the Soux Indians consequently the papers & letters intrusted to their care were all lost some of which, ware of vital importance to Oregon I have also written several letters which hav been sent by sea on board of American Merchantmen but as yet have not received an answer to any. Which places me in rather an awkward position not knowing whether you have recd any of my letters or not. For in former letters I have went into a jeneral description of the country so far as my knowledge of it extendid. Which for fear of repetetion at the preasant I shal defer I am hapy to say that I am in good health, and that this blessing is afforded to all by the mild and celubrious climate of Oregon. Many persons within my knoweledge would have long since fell victims to disease had they not by migrating tither found relief in the fresh and balmy atmosphere of this most excelent clime the onely objection that I have to the country is that there is to much rain falls in the winter season. however they are warm and not injurious to stock the grass is just as good here in January as in July & our farmers sow wheat from Oct til June & raise from 40 to 60 bushells pr acre and all sorts of small grain in proportion. We have had no snow in the vally this winter but occsionly a light frost The emigration of last fall all got in salely [safely] & in good season with the exception of one company. their pilot attempted to bring them into the vally by a new & as they suposed a nearer rout but unfortunately failed and lost them in the middle region of Oregon this company suffered severely for the want of provisions and in many instances for water Our Legislator have passed a bill making provisions for the viewing and location of a new road into the vally when completed will be of great advantage to Emigrants & to the country claims that are improved are selling from \$500 to \$3000 in Oregon currency which consist of stock wheat lumber & salmond or all kinds of produce that will bear transportation the principale part of the business of the country is done by barter our merchants take all kinds of produce in exchange for goods & our people all live well & accumulate property faster here than in any part of the world I have ever bin in, I bougt a farm a few days sinc for which I paid \$1000 it is situated in the Willamett Vally 15 miles above (I am not married yet but have come to the conclusion of doing as Cane did when he the Citty went into the land of Nod[?] we have one printing office & six churches now in the vally and the country is improving beyond all calculation. I send my respects to all the family I am in hopes you will wrigt every oportunity invellope your letters Directed to the PM at Indipendence Mo & they will be brougt throug by the emigrants or otherwise by way of the Sand Wich Islands. I shall continue to wrigt every oportunity as I feell it a duty incumbent upon me & one that will never be forgoten or neglected by me so long as that being by whom I was created shall be pleased to number me among the living of this unjust and unfriendly world. Mother I must now bid you adieu one & all but must first again try to impress upon your mind the anxiety I feel in hearing from you once more it being two years since I have recd a letter There ware some persons came over in the last emigration from Oxford & also some from Hamilton but I could get no information from home

I will say once more that I am plesed with this country and in case the American government sustans her claim as far as the 48 Degree N Latitude which will secure to the Yr[?] Puget Sound, I expect to spend the remainder of my days in Oregon I do not wish to advise any person to come to this country but were I in the states with out much property I should most certainly come to Oregon

Ford who is said to be dangerous Vices of every description are common Money plenty provisions scarce & clothing of every discription high Should I not return this winter I will send you some money by the first as my righting desk is a pile of logs under an oaktree upon the banks of the oportunity sacremento which is not so pleasant as I should desire I will therefore defer any thing further at present give my respects to your Father Mother & children likewise to the Major & Captain & Mr & Mrs Lawton tell Geo Crawford he may expect to here from me in a short time & that I wish him to wright to me every opotunity & direct to Sutters Fort

And you will please do me the favour of dropping a line when ever you can make it conveniant I will now close by once more bidding you an affectionate adieu and at the same time you may rest asshured that I will ere long join with you in the social circle of our own fire side
